Programme at your Institution under The West Bengal University of Teachers' Training, Education Planning and Administration w.e.f. the academic session 2016-2017 subject to the renewal of affiliation every year and fulfillment of the following terms and conditions:

It is advised to make payment to the staff of the college through A/C payee cheque drawn on a (preferably) Nationalized Bank. Stem action shall be taken if any irregularities are found in this regard.

In respect of maintenance of academic and financial discipline the college will strictly follow norms of NCTE (in strict observance of the latest notification)/State Government Orders issued from time to time and relevant conditions/rules of the Affiliating University in this regard especially with respect to the minimum number of teaching days in an academic session as stipulated by the Affiliating University/NCTE.
- Expert(s), duly authorized by the University may make 'surprise visit' to the college for rapid, onspot assessment of the quality of functioning. If any short-fall / discrepancy is identified by the Inspection Team, affiliation of the programme may be withdrawn.

- 9. Admission of students will be as per norms stipulated by the University.
- 10. Staying in the college hostel, if any, is not mandatory for the students.
- 11. The Governing Body of the College is to be constituted as per provisions of the State Govt. / Affiliating University.
